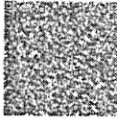

1. The Indian Air Force Educational and cultural society (Name of the Society/~~Trust/ Company under section 8~~) is a registered society / ~~trust~~ under the Societies Registration Act 1860, vide registration no S/11214 (Name of the Act under which society / trust is registered/section).

2. That the Indian Air Force Educational & Cultural Society (Name of the Society/Trust/Company under section 8) is of Non-Propriety Character.

3. That Air Force School Kanakghati is being run as community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.

4. That no part of income from the institution is being, and will be diverted to any individual in the ~~Trust/Society/Company/School—Management Committee~~ or to any other persons/ entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to the developmental, depreciation and contingency funds, will be further utilized for promoting the school and extending the clause of education in the same school only.

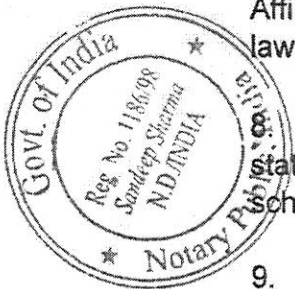
5. That Air Force School Kanakghati is not paying any charges towards using name motto, logo or any other non- academic activities to any other institution, organization or body.

6. That Air Force School Kanakghati will not open classes under CBSE pattern particularly class IX/X/XI/XII, and will not use CBSE name in any manner without obtaining affiliation.

7. That the Principal and correspondent/Manager of the School Kanakghati have individually gone through the provision contained in the affiliation & examination by laws and the circular issued by the Board from time to time. The School undertakes to abide by the provision contained in the Affiliation & examination by laws, direction issued from time to time and the law of the land.

That Air Force School Kanakghati will ensure compliances of all statutory requirements like EPF, ESI and labour laws etc. with respect to the school and staff of the school.

9. That Air Force School Kanakghati will ensure that the building Safety, Fire Safety, Water Safety, Health and Hygiene certificate are being issued or



renewed by the concerned municipal or state authorities from time to time as per prescribed term.

10. That Air Force School Kanakghati will ensure that all required infrastructure is available with the school before starting classes.

11. That Air Force School Kanakghati will ensure that sufficient number of qualified teachers as per the provision contained in affiliation bye-laws are available with the school before starting classes.

12. That Air Force School Kanakghati will follow the provision related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every, year before start of session without resorting to any hidden charges in the heads of the fee.

13. That Air Force School Kanakghati will not coerce any students/parent to buy books/stationery/uniform from any particular shop.

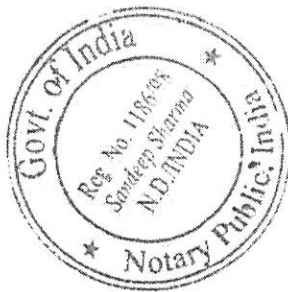
14. That Air Force School Kanakghati shall strive to make efforts for conservation of environment.




17. That Air Force School Kanakghati will not be sponsored from the other board.
